**Topic:** Discussion with MSAA Personal Property Committee

Motion(s)/Comments: Missouri State Assessors' Association (MSAA) Personal Property Committee Chairman, Darrin Gladbach, had the members introduce themselves. Those in attendance were Kent Bryant, Adair County Assessor; Melissa Maupin, Audrain County Assessor; Sherry Smith, Barry County Assessor; Darrin Gladbach, Chariton County Assessor; Kellie Vestal, Crawford County Assessor; Annette Black, Dade County Assessor; Jamie Homeyer, Dent County Assessor; Penny Woods, Gentry County Assessor; Lisa Perry, Jasper County Assessor; Robert Boyer, Jefferson County Assessor; Doug Bowerman, Lawrence County Assessor; Jessica Adcock Goodman, Saline County Assessor; and Michael Dauphin, St. Louis City Assessor.

Mr. Gladbach discussed the history of the car valuation guides and NADA guides to date. The MSAA provided their current contract is the last contract they will be entering into. The STC provided that assessors need to obtain the tools and resources necessary to assess property and it would benefit the MSAA to contract for all members versus each county having that responsibility. MSAA stated they proposed legislation that changed through the legislative process and didn't pass by the end of session. Mr. Gladbach asked some follow-up questions. Mr. Bowerman provided two pieces of correspondence that were sent to the STC, but they never received follow-up correspondence from the STC. SJ provided that she would review emails and provide any responses the STC provided to that correspondence. Follow-up note: SJ provided the STC response for the MSAA correspondence dated September 13, 2022. SJ further provided that the STC has no record of receiving the correspondence dated July 17, 2023.

#### **Informational Meeting, No Vote Taken:**
