Motion(s)/Comments: HS presented the reconciliation spreadsheet and tax credits spreadsheet for changes to the Centrally Assessed Private Car Companies from the tentative report to Certification that will be presented at the 1:30 p.m. Commission Meeting. HS also discussed the companies that were going to receive the 4% penalty for late filings. HS provided that she had contacted the Department of Revenue (DOR) to understand their process once the STC certifies the values to DOR.
