

**Topic:** Pulaski County - Discussion

**Motion(s)/Comments:** LJ presented an email from Daniel Whittle, Pulaski County Assessor, stating Mr. Whittle is rescinding his signed MOU. GKA provided that the STC cannot file suit to prevent an Assessor who has signed an MOU from rescinding his agreement. However, an Assessor who rescinds his/her agreement to the MOU, or an Assessor who refuses to sign an MOU in the first place, thereby signifies to the Commission that he/she has no intention of complying with the Maintenance Plan which requires property to be assessed at or near market value. In an MOU, the Commission does nothing more than ask the Assessor to affirm that he/she will take necessary steps to assess property at or near market value, as required by their Maintenance Plan and by state law. Historically, the Commission has made this request of Assessors whose assessments are significantly below market value so that the Commission would have some assurance the Assessor still intends to comply with their Maintenance Plan. It has provided the Commission an avenue to release assessment maintenance funds to Assessors whose assessments have fallen below legal minimums. However, when an Assessor refuses to make such affirmation, or withdraws such affirmation previously given, thereby expressing a repudiation of the Maintenance Plan, the STC can and should withhold assessment maintenance funds under such circumstances. GWR made a motion to accept Danial Whittle's rescinding of his MOU for Pulaski County, to withhold Pulaski County's FY-2026 assessment maintenance funds in the amount of \$66,240.90, and to send an updated Order to the Pulaski County Board of Equalization that there is no MOU in affect. DM seconded the motion.
