

Topic: Original Assessment Certification, Document #3 – 2025 Amended Certification of Private Car Report to DOR dated 12-30-2025

Motion(s)/Comments: DM made a motion to consider the Original Assessment Certification of Private Car Report to DOR dated December 30, 2025. GAR seconded the motion. MDF presented the 2025 Amended Certification of Private Car Report to Missouri Department of Revenue (DOR) as illustrated on Document #3 dated December 30, 2025. MDF provided the company has been assessed with a 4% penalty for their late filing. The Commission inquired if they would receive their tax bill and be able to pay their bill by December 31, 2025. MDF provided that he alerted DOR that the amendment would be forthcoming, and DOR stated the personnel that typically handles the billing is out for the year and they most likely will not receive their bill until Monday, January 5, 2026.
