# Updating Miles of Line Reported on Schedule 13

Schedule 13 allows companies to update miles of line reported within a political subdivision from one tax year to the next. The column titled '2025 Miles' documents the miles of line reported within each political subdivision in the prior tax year. Any changes to the number of miles of line reported within each political subdivision for the current tax year should be reported The '2025 Miles Updated' column.

# Common Errors Updating Miles

- Duplicate values on the two columns indicate that miles of lines have been updated unnecessarily. Values on both columns should not be similar!

- While the miles of line reported by the company for certain jurisdictions changed, they did not change for the following taxing jurisdictions: Golden City, Liberal FPD, and Jasper County FPD. The '2025 Miles Updated' Column for these taxing jurisdictions should have been left **blank**.
